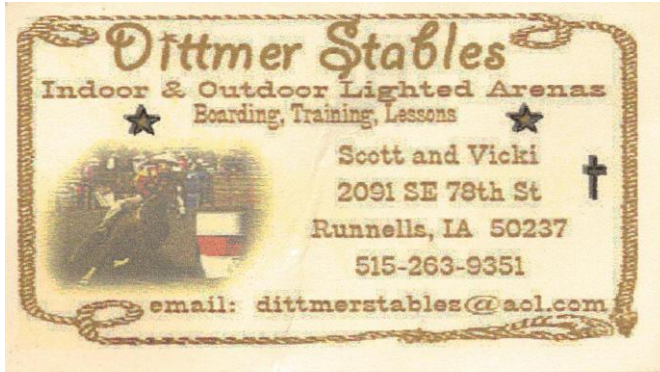

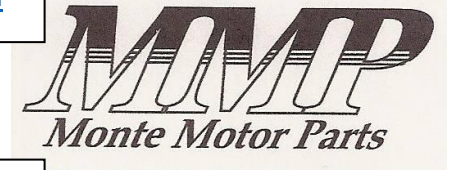

Stock Charge: Increase stock charge by \$1.00 to \$10.00. Excluding Girls Barrel Racing.

Pay off per Event: Change BB and SB to pay out 1 more Hole. Change to read:

- 1-3 Entries Pay 2
- 4-6 Entries Pay 3
- 7-11 Entries Pay 4
- 12-20 Entries pay 5
- 21-30 Entries pay 6

Judge and Judges Method: Pages 34 section 23A Roughstock Page 38 section 6A Bareback Page 41 Section 14B Saddle Bronc- Replace “will be waived” to read “may be waived at the discretion of the judge.”

Pay Off: Page 26 5A Add- in an event that has multiple go rounds and an average, if NO score or time is made in a go around, that money will be added to the average payoff and no ground money will be paid in that go around.

Membership: page 6: Add to rule 6: D. Judges do not need to be an Iowa resident.
